**MUNICIPAL ORDINANCE NO. 002 s. 2018**

**AN ORDINANCE GRANTING ALL DAY CARE WORKERS IN THE MUNICIPALITY OF MAGALLANES ADDITIONAL MONTHLY ALLOWANCE OF FIVE HUNDRED (P500 .00) PESOS EACH, WITH A TOTAL AMOUNT OF NINETY THOUSAND PESOS (P 90,000 .00) CHARGEABLE TO THE GENDER AND DEVELOPMENT (GAD) APPROPRIATION**

WHEREAS, Section 447 of Republic Act No 7160, the Local Government of 1991, states that, "xxx the Sangguniang Bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants xxx";

WHEREAS, the municipal government, recognizes the important role of the Day Care Workers as a support system to ease the multiple burdens of working mothers and improve access to child care facilities as stipulated in the approved Gender and Development Plan of the Municipality;

WHEREAS, there are fifteen (15) day care workers who render their services in every Day Care Center currently receiving three thousand pesos (P3,000.00) monthly allowance;

WHEREAS, this Ordinance is designed to grant additional allowance to the Day Care Workers of this municipality to sustain and improve further their worth-recognizing performance and services;

**SECTION 1. -TITLE.** - This Ordinance shall be known as "AN ORDINANCE GRANTING ADDITIONAL ALLOWANCE TO DAY CARE WORKERS";

**SECTION 2. - COVERAGE.** - This Ordinance shall cover all Day Care Workers handling Day Care classes at all Day Care Centers in the Municipality of Magallanes;

**SECTION 3. - DEFINITION OF TERMS.** This Ordinance defines the following terms:

- a. **DAY CARE WORKERS** - are child development workers who conduct Day Care classes, maintain Day Care Centers and has undergone the required training, in accordance with the law and regulations for the conduct of Day Care programs, and receiving allowances and stipends from local funds but are not regular employees of the municipal government;
- b. **DAY CARE CENTERS** - are the buildings or rooms at the barangays of this Municipality set aside for the purpose of teaching early education classes and supervised by the Municipal Social Welfare and Development Office (MSWDO);
- c. **MSWDO** - This is the Municipal Social Welfare and Development Office headed by the Municipal Social Welfare Officer, a regular department at Municipal Hall in charge of the supervision and close coordination of the Day Care Program.

**SECTION 4. - FUNDING.** - In recognition of the services, all registered Day Care Workers who are actively and regularly performing their duties and responsibilities as certified by the MSWDO shall be entitled to additional allowance for Day Care Workers.

This ordinance set aside the amount equivalent to Five Hundred Pesos (P500.00) monthly to each of the fifteen (15) Day Care Workers for a total amount of Ninety Thousand Pesos (P90,000. 00), chargeable against the GAD appropriation.

The years thereafter, the appropriated amount necessary shall be included in the Annual Budget.

**SECTION 5. - EFFECTIVITY.** - This ordinance shall take effect upon its approval.
